Does Hitachi have a share transfer agreement?

Hitachi Energy Ltd ("Hitachi Energy") today announced that Hitachi,Ltd. (TSE: 6501,"Hitachi") has signed a share transfer agreement for the remaining 19.9% shares from ABB Ltd (SIX: ABBBN,"ABB"), pursuant to the acquisition agreement signed on December 17,2018 (1).

Why is Hitachi energy a wholly owned subsidiary?

By making Hitachi Energy a wholly owned subsidiary,Hitachi intends to further accelerate synergies and innovation through the fusion of the two companies as the global power market undergoes an unprecedented period of change in preparation for the energy transition.

When did Hitachi acquire ABB?

On December 17,2018,Hitachi and ABB signed the acquisition agreement for 80.1% of the shares of the company operating power grids business (now Hitachi Energy) that had been carved out from ABB*1. On July 1,2020,Hitachi acquired 80.1% of the shares of the company*2.
